Subject: Rules Regarding Elections

Elections shall be conducted under the supervision of Election Officers

1. A student cannot propose or second the name of more than one candidate for the same post.
2. In the event of non-receipt of any valid nominations for any post, the election officers shall nominate the suitable candidate on the basis of contribution to that post.
3. No candidate shall hold more than one post (but may be an ordinary member of another society in addition to holding one post).
4. In case, if only one candidate qualifies for a post, the candidate will be unanimously elected for that post.
5. Each student voter can only cast the vote once. Time will be given to students after the manifesto reading to carefully decide their preference. No changes in their preference will be entertained after submission of the voter form.
6. The candidate or candidates with the highest number of votes for a post will be elected to that post.
7. In case of a tie vote, the election officers in conjunction with the two candidates, will decide the outcome of the manifesto reading by the two candidates.

Election Disqualification

In case of any query or clarification, candidates and voters can contact via email on students' association mail with cc to the official election mail.

1. Any candidate who is found guilty of using: Threat in any form, undue Influence, and Coercive Measures, against her fellow candidates during the course of election period.
2. Using any fake email Id to cast the vote/duplicate vote.

Operational definition

Technical glitch: Comply with the inability to open the link or submission of the vote due to network issue, or technical problem from the vendor backend.

(Note: Incorrect filling of the choice of vote cannot be termed as technical glitch)
